The product is from ISO 9001, ISO 14001 and ISO 50001 certified sites in Eastern France.

ECLATEC carries out a full carbon footprint of its activities covering scopes 1, 2 and 3. The footprint is updated every year to accurately track changes in our greenhouse gas emissions. That data is used to define our decarbonisation roadmap, which sets measurable and progressive emission reduction targets.
